(How we use Parent & Carer Information)

The Categories of Parent & Carer Information that Elevate Collects, Holds and Shares Include:

- 🌱 Personal information (such as name, address, telephone number and email address).
- 🌱 Details in respect of pupil premium entitlements and free school meal eligibility (National Insurance Number & date of birth).

Why Elevate Collects and Use this Information;

We use parent & carer data:

- 🌱 To enable routine and emergency contact;
- 🌱 To ensure admission eligibility;
- 🌱 To access grant funding to support student outcomes.

The lawful Basis on Which Elevate Uses this Information;

We collect and use parent & carer information under the following:

General Data Protection Regulations (GDPR) Article 6

- 🌱 Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

General Data Protection Regulations (GDPR) Article 9

- 🌱 Processing is necessary to protect the vital interests of a data subject or another individual where the data subject is physically or legally incapable of giving consent

Collecting Parent & Carer Information;

Whilst the majority of parent & carer information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Storing Parent & Carer Data:

Elevate holds parent & carer data until the child leaves an Elevate Academy.

Why Elevate Shares Parent & Carer information:

We do not share information about parent & carers with anyone without consent unless the law and our policies allow us to do so.

Requesting Access to Your Personal Data:

You also have the right to:

- 🌱 object to processing of personal data that is likely to cause, or is causing, damage or distress;
- 🌱 prevent processing for the purpose of direct marketing;
- 🌱 object to decisions being taken by automated means;
- 🌱 in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- 🌱 claim compensation for damages caused by a breach of the Data Protection regulations
