

Roblox Updates, Age Estimation & Grow a Garden

Revealing Reality Report - Update

As the most popular online game on the planet with children, *Roblox* continues to gets a lot of coverage and understandably so. It's a fun and creative platform to explore, but it isn't without its faults, some of which are very significant. Following on from the April 2025 Revealing Reality Report which raised serious concerns about what children were experiencing within the game, a follow-up investigation has since been conducted to see what, if anything had changed. In short, quite a lot has changed, such as:

- Adjustments to content maturity ratings.
- ID verification for certain games and experiences.
- Stricter moderation
- Enhanced parental controls.

Age Estimation and ID Verification Update

Recently *Roblox* have announced that they are expanding facial age estimation and ID verification to all users who access the communication features within *Roblox*, as well as new systems designed to limit communication between adults and children, unless they know each other in the 'real world'. Whilst the word 'limit' is yet to be fully defined, hopefully this is a step in the right direction. 'Grow a Garden' Game

'Grow a Garden' is one of the latest games available on *Roblox* and is extremely popular. The game is labelled as 'minimal' for content maturity, which *Roblox* define as, "may contain occasional mild violence, light unrealistic blood, and/or occasional mild fear." *Roblox* believe that the game play is suitable for everyone. However, as the game is on *Roblox*, it is important to be aware of the following:

- Chat strangers can interact with your child.
- In-game purchases this game does include in-game purchases.
- Screentime set limits for how long your child is playing.

A lot of the content on *Roblox* is user generated, which may mean not all games will be suitable for your child to view/play. If your child is playing *Roblox*, it is important to monitor what your child is accessing, ensure they know how to use any reporting tools and set up appropriate parental controls.
