Rationale

On very rare occasions it may be necessary to quickly restrict access and egress to a site or building (or part of) through physical measures in response to a threat, either external or internal. This will ensure that pupils, staff and visitors are safe in situations where there is a hazard in the school grounds or outside the school in the near vicinity.

Lockdown procedures should be seen as a sensible and proportionate response to any external or internal incident which has the potential to pose a threat to the safety of staff and pupils in the school. Procedures should aim to minimise disruption to the learning environment whilst ensuring the safety of all pupils and staff.

Lockdown procedures may be activated in response to any number of situations, but some of the more typical might be:

- A reported incident / civil disturbance in the local community (with the potential to pose a risk to staff and pupils in the school
- An intruder on the school site (with the potential to pose a risk to staff and pupils)
- A warning being received regarding a risk locally, of air pollution (smoke plume, gas cloud etc.
- A major fire in the vicinity of the school

• A bomb threat (please see **Emergency Planning Procedures** for further information)

Lock Down Plan

Staff will be notified that lock down procedures are to immediately take place when the lockdown siren is activated. This warning sound is repeated until Glynis Wiles instructs staff to turn the warning off.

Procedures:

- This auditory signal will activate a process of children being ushered into the school building if on the playground as quickly as possible and the locking of all outside doors and windows.
- 2. At the given signal the children will remain in the room they are in and the staff will ensure that all windows and doors are closed/locked and screened where possible and children are positioned away from possible sightlines from external windows/doors. Lights, Smart boards and computer monitors to be turned off. All blinds to be closed.
- Front office staff to ensure that their windows are locked, metal internal shutters are closed. Office staff to contact emergency services and Milton Keynes LA 01908 311773
- 4. Front office staff will guide any visitors waiting in reception into a safe area: DHT office.
- 5. Children or staff not in class for any reason will proceed to the nearest occupied classroom and remain with that class and class teacher (e.g. children using toilets) who will notify the child's class teacher.
- 6. Lock Down grab sheet to be followed
- 7. Registration of children to be undertaken in class using class registers.

- 8. Notify Glynis via telephone <u>as soon as registers</u> are completed. Inform the office if you have any additional adults in your class or volunteers
- 9. Non-class based professionals and visiting professionals to notify the office from their rooms. (Premises, nursing team etc)
 Any missing children must be reported to Glynis as to when last seen and possible areas to search. Date of time and notification of a missing child/children should be recorded.
- 10. NO ONE SHOULD MOVE ABOUT THE SCHOOL
- 11. Staff to support children in keeping calm and quiet.
- 12.INDIVIDUAL STAFF CANNOT SIGN OUT OR LEAVE THE PREMISES DURING LOCKDOWN Office team will send a lock down text message to staff, parents/carers who are volunteers, mid days and cleaners who arrive during the day.
- 13. Staff to remain in lockdown positions until informed by key staff e.g. SLT, Office team, Chair of Governors or emergency service(s) in person.
- 14. SLT will convene in AHT/SENDCo room, away from the door and window. This will enable SLT and office team to communicate freely.
- 15. Crisis Management Team (CMT) to undertake dynamic risk assessment during any lockdown/critical incident children are priority.
- 16. As soon as possible after the lockdown teachers return to their base classrooms and conduct a roll call and notify the office immediately of any pupils not accounted for.
- 17. Crisis management team to meet and follow **Emergency Planning Procedures.**

During and following a Lock Down, the use of Social Network sites (e.g. Facebook and Twitter etc) and School Gateway during the school day is strictly prohibited until the Headteacher or a member of the crisis management team informs staff differently.

Communication with parents

If necessary, parents and carers will be notified as soon as it is practical to do so via parentmail. The crisis management team will send out these communications and these should not be sent by class teams.

Parents will be told

'Giffard Park Primary School is in lockdown. During this period the office phones and entrances will be un-manned, external doors are locked and nobody is allowed in or out'

Depending on the type and severity of the incident, parents and carers may be asked NOT to collect children from school as it may put them and their child at risk. Pupils will not be released to parents/carers during a lock down. Parents/carers will

be asked not to call school as this may tie up emergency lines. If the end of the day is extended due to the lock down, parents/carers will be notified and will receive information about the time and place pupils can be picked up from office staff or emergency services. A letter to parents/carers will be sent home at the nearest possible day following any serious incident to inform them of the context of lockdown and to encourage parent to reinforce with their children the importance of following procedures in these very rare circumstances.

Emergency Services

Lines of communication with Emergency Services will be kept open as they are best placed to offer advice as a situation unfolds. The school site may or may not be cordoned off by Emergency Services depending on the severity of the incident that has triggered the Lockdown.

Emergency Services will support the decision of the Headteacher with regarding the timing of communication to parents.

In the event of a prolonged lockdown or more severe scenario, Milton Keynes Council Emergency Planning team has the capacity to provide humanitarian assistance by establishing a reception centre for friends and family outside of the cordoned area.

Partial Lockdown

Alert to staff: 'Partial lockdown' This may be as a result of a reported incident/ civil disturbance in the local community with the potential to pose a risk to staff and pupils in the school. It may also be as a result of a warning being received regarding the risk of air pollution, etc.

Staff will be notified that partial lock down procedures are to immediately take place on hearing the lock down alarm siren.

Immediate action:

All outside activity to cease immediately, pupils and staff return to building.

All staff and pupils remain in building and external doors and windows locked Movement may permitted within the building dependent upon circumstances but this must be supervised by a member of staff (SLT).

All situations are different, once all staff and pupils are safely inside, senior staff will conduct an on-going and dynamic risk assessment based on advice from the Emergency Services. This can then be communicated to staff and pupils.

'Partial lockdown' is a precautionary measure but puts the school in a state of readiness (whilst retaining a degree of normality) should the situation escalate.

Lockdown drills

Lock down practices will take place a minimum of once a year to ensure everyone knows exactly what to do in such a situation. Monitoring of procedures will take place and shared with staff so improvements can be made.

Conclusion




Initial response - lockdown	Tick / sign / time
Ensure all pupils are inside the school building.	
Class teachers are responsible for own class.	
Lock / secure entrance points (e.g. doors, windows) to prevent the intruder entering the building	
Dial 999. Dial once for each emergency service that you require	
Ensure people take action to increase protection from attack:	
Block access points (e.g. move furniture to obstruct doorways)	
Sit on the floor away from the windows	
Keep out of sight	
Draw curtains / blinds	
Turn off lights	
Stay away from windows and doors	
Staff to support children in keeping calm and quiet	
Ensure that pupils, staff and visitors are aware of an exit point in	
case the intruder does manage to gain access	
If possible, check for missing / injured pupils, staff and visitors.	
Remain inside until an all-clear has been given, or unless told to evacuate by the emergency services	



Lock Down Drill



- A lock down drill is not a fire drill
- It means there could be danger outside or inside the school
- We will hear a very loud lock down warning alarm
- This means we must walk quickly inside if we are outside
- We must all sit on the floor
- Adults will close the blinds
- NO talking
